## District 7210 Finance Committee Proposed 2021-22 District Budget & Audit of 2020-21 Finances February 3, 2021

To all Rotary District 7210 Club Presidents and Presidents-Elect;

The District Finance Committee met on January 20, 2021 to evaluate and discuss the Proposed 2021-22 District Budget (see attached), as prepared under the direction of District Governor Elect Mike Polasek at which time our Finance Committee unanimously approved this Budget. The highlights of this Budget can be summarized as follows:

- The total Budget of \$222,000 represents a 5.1% decrease from the 2019-20 budget and no change from 2020-21.
- The dues for each member will not increase and remain at \$49/member.
- Over half of the total Budget is for programs which typically generate income equaling their expenses each year, such as our Foundation Grants, RYLA and Youth Exchange.
- The remaining amount of the Budget is primarily used for our Club leader and member training programs (such as PETS, Assembly, Service Symposium, Zone Institute, RI Convention, etc.) and the District leadership who facilitate these programs.
- The most significant of these training programs is for our multi-district President Elect Training Seminar (PETS), which is budgeted to cost \$28,000 in this budget year (this anticipates a high level of participation and assumes an in-person event for 2022). There will be \$495/club training fee for the PETS Assessment. However, since the 2021 PETS will be held virtually and there is very little expense, each Club will receive a \$495/club full credit toward the 2021-22 dues.

At this meeting, the District Finance Committee also reviewed and discussed the completed 2019-20 financial records, noting the while there was a small surplus. The 2019-20 Financial Statement Review prepared by Matthew H. Metzger CPA of New Paltz, New York can be found on our District website.

The 2021-22 District Budget and the 2019-20 Review will be reviewed during an online District Legislation Meeting on Thursday, March 4, 2021 at 4pm (digital invitation to be sent/posted immediately prior to that date), with a vote by Club Ballot to be returned no later than March 9, 2021. Further information regarding this Legislation Meeting and the voting process will be provided under separate cover.

#### Rotary International – District 7210 Middletown, New York Notes to Financial Statements

### Note 1 SUMMARY OF SIGNFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Rotary International-District 7210 is presented to assist in understanding the organization's financial statements. The financial statements and notes are representations of the organization's management who is responsible for their integrity and objectivity. These accounting policies conform to generally accepted accounting principles and have been consistently applied in the preparation of the financial statements.

#### Type of Organization

Rotary International-District 7210 is a tax exempt organization under Section 501c(4) of the Internal Revenue Code. Rotary International is an association of Rotary Clubs within an assigned geographic area in New York State. The District provides administrative services to 55 clubs and 1,525 members in its area including the piloting of benevolent projects and the coordination of activities with Rotary International.

#### **Basis of Accounting**

The financial statements of Rotary International-District 7210 have been prepared on the accrual basis of accounting and, accordingly, reflect all significant receivables, payables, and other liabilities.

#### **Basis of Presentation**

Financial statement presentation follows the recommendation of the Financial Accounting Standards (SFAS) No. 117, Financial Statements of Not-for-Profit Organizations. Under SFAS No. 117, Rotary International-District 7210 is required to report information regarding its financial position and activities according to the three classes of fund balance: Unrestricted Fund Balance, Temporarily Restricted Fund Balance, and Permanently Restricted Fund Balance. Rotary International-District 7210 has no permanently restricted fund balance for year ended June 30, 2020.

Under the provision of SFAS no. 117, net assets and revenues, expenses, gains and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, the net assets of the organization and changes therein are classified and reported as follows:

Unrestricted Net Assets – net assets that are not subject to donor-imposed stipulations.

Temporarily Restricted Net Assets – net assets, which carry specific donor-imposed stipulations that can be fulfilled by actions of the District pursuant to those stipulated or that expire by the pass of time.

Permanently Restricted Net Assets – net assets, which have been restricted by donors to be maintained by the District in perpetuity.

Revenues are reported as increases in unrestricted net assets unless use of the related assets is limited by donor-imposed restrictions. Expenses are reported as decreases in unrestricted net assets. Gains and losses on investments and other assets or liabilities are reported as increases or decreases in unrestricted net assets unless their use is restricted by explicit donor stipulation or by law. Expirations of temporary restrictions on net assets are reported as net assets released from restrictions.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### Cash and Cash Equivalents

For the purpose of the statement of cash flows, the organization considers cash and all highly liquid investments with original maturities of three months or less to be cash equivalents.

#### Accounts Receivable

Receivables from members are reported at the amount management expects to collect on balances outstanding at year-end. It is concluded that all balances outstanding at year-end will be collected.

#### Pandemic - COVID-19

COVID-19 has been declared a pandemic by the World Health Organization. The effects of COVID-19 continue to evolve and the long-term economic and business consequences remain uncertain. The longer this pandemic continues, the more costly it may become to the Rotary International-District 7210. With many of the planned trainings being cancelled in the spring of 2020 because of the pandemic, the Board of Directors decided to refund \$325 per club for a total of \$17,875. This is included in the Accounts Payable at June 30, 2020. The Rotary Youth Leadership Academy (RYLA) was cancelled in June of 2020 as well as the Youth Exchange for 2020-21.

Based upon the great success of the 2019-20 District Conference (now renamed to be the District Service Symposium) which was held at the Resorts World Catskills in our District at Monticello, New York, the District Executive Board, serving in the role formerly served by the Conference Advisory Committee, is pleased to propose that the 2021-22 District Conference be held once again at Resorts World Catskills.
