Dear Club Foundation President and Treasurer:

This is a critically important letter, to which your prompt and serious attention must be given. If you have questions after reading it, please contact me or Shawna Kaiser, Executive Director, at (312) 427-4410 or <u>foundation@altrusa.org</u>.

The 2020-2021 local club foundation annual report following this letter is due to the Foundation by **Friday, December 17**.

Failure to submit the report will result in removal from the International Foundation's 501c3 "umbrella".

Note: The Foundation Board of Trustees voted to require certain revisions to local club foundation bylaws and to strongly suggest the adoption of policies regarding the operations of local club foundations. The revised templates of those bylaws and policies are linked at https://foundation.altrusa.org/governance/. Reporting of revisions of bylaws and adoption of policies by your local club foundation board is due to the Foundation office by June 1, 2022.

Maintaining the Corporation of the Local Club Foundation

If your club foundation has taken steps to officially form a non-profit corporation, using instructions from your state, the International Foundation needs to know the date of incorporation of your club foundation (this should be something you can determine from a state website or from your records) on the form. Note that receiving approval of Articles of Incorporation and Bylaws from the Legal Advisor and/or the International Office is not the end of the process -generally, you must file those Articles of Incorporation with your state – in order to incorporate.

If you have filed your club foundation's approved Articles of Incorporation with your state, as directed in the materials for club foundation formation provided by International, please provide us (on the form) with the date such articles were filed.

If you have not yet done so, those articles must be filed with the appropriate state authority. On the form, please confirm your intent to do so, and tell us which club member will be responsible.

If, like some club foundations, you are simply "calling" your foundation a non-profit corporation, it is time for you to take the steps necessary to actually form a non-profit corporation recognized by your state. This usually is a relatively simple task involving the filling out of a form and the payment of a very small fee. On the form, please confirm to us your intent to do so, and tell us who in your club will be responsible for undertaking this task.

Directors & Officers Insurance

The Cook & Kocher insurance agent for Altrusa International, Inc. and the International Foundation recommend that all local club foundations invest individually in Directors & Officers insurance policies. Currently, all local club foundations are covered under the Altrusa International, Inc. policy, but that coverage is limited and should not be entirely relied upon. The International Foundation is unable to secure additional coverage for local club foundations and will no longer invoice them for insurance coverage.

State and Federal Compliance:

Once formed, a corporation must be kept in good standing with the state of incorporation, typically by responding to the state's request for updated information. Thus, if your club foundation's agent for service changes, or changes address, that new information should be sent to your state authority. Please confirm, on the form, that your club foundation is in good standing.

If your corporation has forfeited its status by failing to file a periodic report, the process to reinstate is usually quite simple, and it is critical that you do so, and that you tell us so on the form.

Filing Tax Form 990-N:

Each year, by October 15th (because Altrusa's fiscal year ends May 31), each club foundation (and each club, as well) must file Form 990-N (the e-Postcard) with the IRS; this is the required filing for non-profits with gross income of \$50,000 or less. If your club foundation's gross income exceeds \$50,000 but is less than \$200,000 (and total assets are less than \$500,000), the Form 990-EZ should be filed. Foundations with gross receipts of more than \$200,000 and assets of more than \$500,000 must file a Form 1090. On the form, p l ease provide us with confirmation that your club foundation has filed the appropriate Form 990 for 2019, and forward to us a copy of that filing, as well. If this has not been done, it is imperative that it be done, and that you tell us on the form which Altrusans are responsible for taking this action.

State Raffle Law Compliance:

Raffles are a common form of fundraising for club foundations. Raffles are closely regulated by states, as they can be considered games of chance or gambling. Your annual confirmation that you are aware of your state's regulations and that any raffles are in compliance with them (some states prohibit them altogether) is necessary.
