

Recognized with a special Paul Harris emblazoned label pin with diamond and a crystal plaque for display, members of the Bequest Society pledge a minimum of \$10,000 to TRF upon their passing through their will/trust or insurance benefits.

Some Cash - Some Bequest

- Make the choice to blend some <u>cash</u> with some <u>bequest</u> to qualify for the dinner.
- Consider joining the Paul Harris or Sunflower Societies and your commitments of new pledges over the next three years will go toward your qualification. For example:
- If you're already generously donating \$1,000 to TRF as a Paul Harris Society member, your cash commitment to your \$10,000 qualification can increase by joining the Sunflower Society, a \$2,500 annual pledge to TRF. The \$1,500/yr. increase in your current \$1,000/yr. pledge will go towards your dinner qualification over the next 3 years. Thereby \$1,500/yr., or \$4,500, in cash towards your qualification. The remaining \$5,500 can be made up by increasing your bequest to TRF in your will/trust.
